- i. Motion to accept the treasurer report by Sue S. and seconded by Pat O.
- II. Business
 - a. Motion made for a Memorial Meeting for Mary S, seconded by Sue S. Discussion: Lorraine W to be part of planning the memorial for Monday April 13th. The speaker
