- VIII. Old Business
 - A. Order of Meeting—we were to vote on where we place the newcomers request to share. Request for comments on how it is going since it has been trialed setting aside time for the newcomer to share when it is sharing time:

Lorraine W. and Norma W. both moderated and tried the new order to invites newcomers/returning members to speaker. Norma asked for sponsors first and then asking for newcomers/new to the meeting/returning members to identify themselves. After the newcomers/new to the meeting/returning members identified themselves, then invited the individuals to share. Shares were made and Norma reported receiving positive feedback. Lorraine did the same. She asked the newcomers/new to the meeting/returning members to identify themselves first. Two returning members identified themselves and one shared. She then went to sponsors. Clarification of what newcomers sharing meant. Counterpoint: not all newcomers need to share, but some do need to share. Counterpoint: Script suggesting they attend at least 6 meetings before they commit themselves is not being mentioned. Question if we are getting rid of that section. Response: this section has not been in the script for a while confirmed by both Lorraine and Norma. Response: the newcomer greeting should be reaching out with that information and to ask the person to identify as a newcomer for at least a month. The 6 meetings portion of the script will be placed on the agenda for August since it is a separate discussion. Norma purposes that after the speaker, to do half time before general sharing. Call for sponsors, and then for newcomers/new to the meeting/returning members to OA, to identify themselves. If someone speaks up, then ask them to share for 3 minutes before the general sharing. Gladys made the motion and it was seconded by Leah J. Clarifications: Change the script right after the speaker or right after half time and it needs to include newcomers/new to the meeting/returning members. Motion on the floor is "that after sponsors are identified and before general sharing, moderators announce are there newcomers/new to the meeting/returning members would they like to share now? And you have 3 mintues." Counterpoint: try the one way for a month and the other for the second month. Discussion if the placement should be the option of the moderator. Motion made according to the original motion (newcomers/new to the meeting/returning members to share after half time.) Lorraine W. motioned the above and seconded by Gladys H. Vote was 15 in favor and 2 opposed.
